It is our pleasure to allow you to use the ranch as a backdrop for beautiful engagement photos. There are many opportunities for unique and artistic shots that we will be happy to point out, if we do not have other appointments and time permits.

Currently, we are able to offer at no charge to you a complimentary engagement photo session. We ask a few things in return:

1. **Schedule an appointment.** *Complimentary engagement photo sessions are for a maximum of two hours beginning on the hour. We will make every attempt to honor your appointment time. On rare occasion, we may ask you to terminate, relocate, or reschedule to accommodate ranch activities. (*Photo shoots are complimentary if you provide us with a disk of full resolution photos. Otherwise, there is a \$100 charge for the two-hour session.)
2. **Leave things as you found them.** If you need to move something, go ahead, but put it back.
3. **Please don't block** roads, walkways, or park in undesignated areas.
4. **Check in** when you arrive and leave at the office building.
5. **Dressing area.** If you schedule a shoot during regular office hours, you may use the restroom in the office building as a changing area. If it is after hours, you will not have access to a changing area so please plan accordingly.
6. **Your personal belongings** and your client's are your responsibility. Do not leave valuables unattended.
7. **Be careful.** There are the typical hazards associated with water and ranchland—including spiders, snakes, wildlife, and yes, an occasional alligator visitor.
8. **Drive slowly.** 15 mph and watch carefully around blind corners.
9. **Share** your great shots with us by email or Dropbox. We love to post wedding and engagement photos on our Pinterest board—we will give your photo credits as you specify (and a link to your website if you wish) It is a great advertising opportunity for both of us.
10. **Sign this release and indemnity form.** This makes our insurance company happy.

By making a reservation for portrait photography at Rock Lake Ranch, you and your client agree to indemnify Rock Lake Ranch, Rock Lake Ranch Events, LLC, and their officers, agents and employees (the "Rock Lake Ranch Parties") from, and hold them harmless against, any and all claims, losses or damages, including death or injury to any persons or property, which may arise out of or occur in connection with your photo shoot and/or your presence on the Rock Lake Ranch property, regardless of whether such claims, losses or damages are caused or are alleged to be caused in whole or in part by the negligence (whether active, passive, sole or concurrent) or other fault of any of the Rock Lake Ranch Parties.
